

CONSENT TO THE PROCESSING OF PERSONAL DATA

1. By granting this consent to the processing of personal data, you consent to the Prague.bio, z. s., with its registered office at Flemingovo náměstí 542/2, Dejvice, 160 00 Prague 6, ID No.: 19641052, registered in the public register kept by the Municipal Court in Prague section I, insert 78057 (hereinafter referred to as "Controller" or "Prague.bio"), within the meaning of Regulation (EU) No. 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as "GDPR"), processed your personal data in accordance with the following terms and conditions:

Scope of processing of your personal data:

The Controller will process following personal data:

- Photos;
- Audiovisual recordings including your appearance;

("personal data") both taken during the Prague.bio Conference 2025 held on 25th September 2025 ("Conference") or provided by you before the Conference.

Purposes of processing your personal data

2. Your personal data will be used for purposes as follows:
 - a. Live stream
The Conference and especially the presentations of the speakers, will be streamed on the YouTube platform on channel: https://www.youtube.com/@Prague_bio_Conference, exclusively for registered participants of the Prague.bio Conference 2025.
 - b. Promotional materials for Prague.bio
Personal data will be used for the purpose of promoting Prague.bio and its future conferences through promotional materials such as brochures, leaflets, videos etc. that may be published on the Prague.bio website and on Prague.bio social networks (including Youtube.com) or provided to media or advertising providers, both in electronic and printed form where possible.
3. The Controller will process your personal data in connection with the purposes stated above for a period of 5 years after you have given your consent to the Controller.
4. You give your express consent to the above processing. The provision of personal data is voluntary. You can withdraw your consent at any time, free of charge, by sending an email info@prague.bio. Withdrawal of consent does not affect the lawfulness of processing based on consent given prior to withdrawal. The withdrawal of consent also does not affect the processing of personal data that the Controller processes on a legal basis other than consent.
5. The processing of personal data is carried out by the Controller; however, the following processors may also process personal data for the Controller:

- i. other providers of processing software, services and applications, but not currently used by Prague.bio;
- j. providers of promotional services, e.g., marketing experts.

6. Please note that under the GDPR you have the right to:

- Withdraw your consent at any time,
- request information from us about what personal data we process about you, request a copy of that data,
- request access to this data from us and have it updated or corrected, or request a restriction on processing,
- object to or complain about the processing of personal data,
- require us to delete such personal data,
- on data portability,
- file a complaint with the Office for Personal Data Protection (in Czech: *Úřad pro ochranu osobních údajů*) or go to court.
